# RE: Privacy policy under the terms of art. 13 of Italian Legislative Decree No. 196 of 30.06.2003 regarding the processing of personal details.

The undersigned COLOR TECH SRL informs that for the purposes of entering into and carrying out our current contractual relationships with you it is in possession of personal and fiscal data acquired directly verbally or through third parties relating to you and that such data are classified as personal under Italian law. With reference to such data, we inform you that:

- 1. The data are processed for the purposes of contractual needs and the consequent fulfilment of legal and contractual obligations deriving therefrom, as well as for the purpose of effective management of our trade relationships.
- 2. The data are processed in written form and/or with magnetic, electronic or telecommunications systems;
- 3. Provision of said data is compulsory for whatever is required by legal and contractual obligations. Refusal to provide them or allow their processing can mean:
  - The undersigned cannot proceed with the contractual relationships involved;
  - Certain operations cannot be carried out that presuppose communication of the data to subjects whose functions are connected to such operations;
  - Failure to communicate data to subjects who carry out other activities not functionally connected with the relationship;
- 4. Failure to provide all the data required for other purposes than the fulfilment of legal or contractual obligations shall be assessed as and when necessary by the writer in order to make a decision that takes into account the importance of the data required in the management of a trade relationship;
- 5. Subject to communication and distribution carried out in order to fulfil legal obligations, the data can be communicated in Italy and/or abroad to:
  - Our network of agents
  - Factoring companies, banks, credit recovery agencies
  - Credit insurance companies
  - Credit reporting agencies
  - Professional experts and consultants
  - Carrier
  - Subjects who are authorised by law to access your data;
- 6. The data shall be processed for the duration of our contractual relationships and after in order to fulfil all legal requirements and for the purposes of future trade;
- 7. In relation to said data, your company may exercise the rights laid down in art. 7 of Italian Legislative Decree No. 196/2003 (copy attached) within the limits and on the conditions in arts. 8, 9 and 10 of said Legislative Decree;
- 8. The data controller is COLOR TECH SRL, Via dell'industria, 6 31020 San Polo di Piave (TV);
- 9. The data processor is Montagner Marco Legal Representative, whose address for the purposes of the law is COLOR TECH SRL, Via dell'Industria, 6 31020 San Polo di Piave (TV).

### ATTACHMENT: ABSTRACT FROM SECTION II OF LEGISLATIVE DECREE 196/03 'DATA SUBJECT'S RIGHTS'

## Art. 7 – Right to access personal data and other rights

- 1. Data subjects shall have the right to obtain confirmation as to whether or not personal data concerning them exist, regardless of their being already recorded, and communication of such data in intelligible form.
- 2. Data subjects shall have the right to be informed:
  - a. of the source of the personal data;
  - b. of the purposes and methods of processing;
  - c. of the logic applied to the processing, if the latter is carried out with the help of electronic means;
  - d. of the identification data concerning the data controller, data processors and the representative designated as per Section 5 (2);
  - e. of the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know said data in their capacity as designated representative(s) in the State's territory, data processor(s) or person(s) in charge of the processing.
- 3. Data subjects shall have the right to obtain:
  - a. updating, rectification or, where interested therein, integration of the data;
  - b. erasure, anonymisation or blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed;
  - c. certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
- 4. Data subjects shall have the right to object, in whole or in part:
  - a. on legitimate grounds, to the processing of personal data concerning them, even though they are relevant to the purpose of the collection;
  - b. to the processing of personal data concerning them, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.
